**Early terminations:** Early terminations of service are subject to a \$700 early cancellation fee per terminal. Notice of termination should be via email to deactivation@globalcomsatphone.com no less than thirty (30) days prior to the expiration of any term of this Agreement. Service is not cancelled until the customer has received an email confirmation. Globalcom reserves the right to terminate this Contract at any time during the contract period.

**Returns:** Only new, unopened items eligible for return. Prior approval required. 15% restocking fee will apply for approved returns.
